## **ORDINANCES FOR ADOPTION**

### **FINANCE ORDINANCE**

- Airey - 1. Ord. Cal. No. 7216 - Ordinance to amend the 2023 Capital Improvement Budget and Capital Assets - Amendment No. 10 - Sewer/Water Quality Capital Projects. (Airey/Cooper) (Introduced 03/02/2023)
- Canulette – asked Leslie Long to explain the purpose of this.
- Long – explained the purpose.
- Smith – moved to adopt, seconded by Laughlin. Unanimous with 3 absent (Dean, Fitzgerald, Toledano); becomes Ord. C.S. No. 23-5109.

### **PRECINCT BOUNDARIES ORDINANCE**

- Airey - 2. Ord. Cal. No. 7230AA - Ordinance to update and realign precinct boundaries, including splitting or merging certain precincts to conform with state law; to clarify and correct precinct boundary descriptions; to improve the configuration of precincts to facilitate parish council district configurations in response to the next federal decennial census; to ordain that polling places are to be established by resolution; to conform the descriptions of parish council districts by referring to the numbering of the realigned precincts; and for related purposes. (Airey) (Introduced as amended 03/02/2023)
  - Cazaubon – made comments about notifying constituents of changes beforehand.
  - Campo – explained that constituents will get new voter registration cards.
  - Binder – asked about one of his precincts going away. Said he would like to find what precinct it merged with.
  - Randolph – moved to adopt, seconded by Canulette. Unanimous with 3 absent (Dean, Fitzgerald, Canulette); becomes Ord. C.S. No.- 23-5110.
- There being no further business, meeting adjourned at the call of the Chairman.
