# ADMINISTRATIVE COMMENT AMENDMENT NO. 17 - 2023 CAPITAL IMPROVEMENTS - APRIL 2023

### SECTION II: CAPITAL IMPROVEMENTS - FACILITIES

#### **CAPITAL PROJECTS - 252-2422 - FISHING PIER FACILITIES**

#### Fishing Pier-Hurricane Ida

Scope: Assess the fishing pier, office, bathroom building, parking lot, road, and any other Parish-owned buildings or equipment associated with the St. Tammany Parish Fishing Pier for repairs due to Hurricane Ida, and develop construction documents for the repair and mitigation of the pier and associated structures.

The damage assessment as prepared by Meyer Engineers was submitted to FEMA in order to request public assistance under Disaster 4611 (Hurricane Ida) for the repairs and mitigation of the St. Tammany Parish Fishing Pier and related facilities. FEMA is currently reviewing the assessment and will prepare a project based on the authorized repairs and mitigation measures, including design costs. The Economic Development funding is being used to prepare the design, so the project is moving concurrently with the FEMA obligation process to avoid delays.

The intent is to reimburse the economic development fund for design work once the project is obligated by FEMA. The local cost share of 10% and any ineligible FEMA expenditures for the pier repair will be funded from the ED fund after utilizing available grant funds from the BP Tourism Grant of \$338,330.03. Based on the estimated \$2,500,000 project costs, a \$250,000 local cost share is anticipated.

Status: Meyer Engineers completed their damage assessment and mitigation recommendations for the St. Tammany Fishing Pier Hurricane Ida damage on February 28, 2023. The damage assessment report will be submitted to FEMA for review and determination of funding. This process has historically taken 2-3 months to receive a response from FEMA. The Meyer Engineers damage assessment will also be submitted to the insurance adjuster to request a review and adjustment of funding. Insurance proceeds are currently \$39,000.00. This is sufficient to fund Phase 1 of Meyer Engineers' contract, which includes the damage assessment, mitigation recommendations, and any FEMA negotiations. Phase 2 for Meyer is to include preliminary design, geotechnical, surveying, permitting, and construction documents. The Phase 2 contract for design costs is expected to be approximately \$450,000.00. Construction costs are expected to be approximately \$2,500,000.00 depending on selected/approved mitigation efforts. Meyer estimates the construction documents will take 8 months to complete. FEMA approval of funding is expected to take 2-3 months; therefore, we will request a budget amendment for \$500,000.00 of Parish funds to cover and expedite the construction documents. This would put us on schedule to complete construction documents by December 2023, bid the project out, and complete construction by December 2024. The complexity of the infrastructure associated with the pier structure and the uncertainty of mitigation design prevent any preliminary work from being performed on the pier at this time. The fire suppression system, lift stations, and electrical distribution systems were severely damaged. The wooden section of the boardwalk connecting the concrete bridge (old Twin Span) to the jetty was severely damaged as well. This section is the main mitigation effort that will be re-designed to prevent future storm water damage.
