A resolution providing for canvassing the returns and declaring the results of the special election held in the Parish of St. Tammany, State of Louisiana, on Saturday, April 29, 2023, to authorize the renewal of a special tax therein.

BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana

(the "Governing Authority"), acting as the governing authority of the Parish of St. Tammany, State

of Louisiana, (the "Parish"), that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of St. Tammany, State of Louisiana, on SATURDAY, APRIL 29, 2023 (the "Election"), to authorize the renewal of a special tax therein pursuant to the following proposition (the "Proposition"):

PROPOSITION (CORONER'S TAX RENEWAL)

Shall the Parish of St. Tammany, State of Louisiana (the "Parish"), continue to levy a three and ten hundredths (3.10) mills tax on all the property subject to taxation in said Parish (an estimated \$7,752,700 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of twenty (20) years, beginning with the year 2025 and ending with the year 2044, for the purpose of providing funding for the St. Tammany Parish Coroner's Office, including constructing, acquiring, improving, operating and maintaining facilities (including the DNA lab) and equipment therefor?

This Governing Authority does further proceed to examine and canvass the returns of the Election thereof.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Election, there was a total of _______ votes cast **IN FAVOR OF** Proposition and a total of _______ votes cast **AGAINST** Proposition, resulting in a majority of ______ votes cast **IN FAVOR OF** Proposition. SECTION 3. <u>Promulgation of Election Result.</u> The results of said election shall be promulgated by publication in the manner provided by law, after receipt from the Secretary of State's office of the actual costs of the election, as required by Act 205 of the Regular Session of the Legislature of Louisiana for the year 2019.

SECTION 4. <u>Declaration</u>. The foregoing results of the Election are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. <u>Procès Verbal</u>. A *Procès Verbal* of the canvass of the returns of the Election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of St. Tammany, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

NOTICE OF SPECIAL ELECTION

Pursuant to the provisions of a resolution adopted by the Parish Council of the Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of St. Tammany, State of Louisiana (the "Parish"), on January 5, 2023, NOTICE IS HEREBY GIVEN that a special election will be held within the Parish on **SATURDAY, APRIL 29, 2023**, and that at the said election there will be submitted to all registered voters in the Parish qualified and entitled to vote at the said election under the Constitution and Laws of the State of Louisiana and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION

(CORONER'S TAX RENEWAL)

Shall the Parish of St. Tammany, State of Louisiana (the "Parish"), continue to levy a three and ten hundredths (3.10) mills tax on all the property subject to taxation in said Parish (an estimated \$7,752,700 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of twenty (20) years, beginning with the year 2025 and ending with the year 2044, for the purpose of providing funding for the St. Tammany Parish Coroner's Office, including constructing, acquiring, improving, operating and maintaining facilities (including the DNA lab) and equipment therefor?

Said special election will be held at each and every polling place in the Parish of St. Tammany, which polls will open at seven o'clock (7:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541.

The polling places at the precincts in the Parish are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, shall be those persons designated according to law.

The estimated cost of this election as determined by the Secretary of State based upon the provisions of Chapter 8-A of Title 18 and actual costs of similar elections is \$101,000.

Notice is further given that a portion of the monies collected from the tax described in the Proposition shall be remitted to certain state and statewide retirement systems in the manner required by law.

The said special election will be held in accordance with the applicable provisions of Chapter 5 and Chapter 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, and the officers appointed to hold the said election, as provided in this Notice of Special Election, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, will make due returns thereof to said Governing Authority, and NOTICE IS HEREBY FURTHER GIVEN that the Governing Authority will meet at its regular meeting place, the Council Chambers of the Parish Government Complex, 21490 Koop Drive, Mandeville, Louisiana, on **THURSDAY, MAY 4, 2023**, at **SIX O'CLOCK (6:00) P.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election. All registered voters of the Parish are entitled to vote at said special election and voting machines will be used.
