ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 16  
PARISHWIDE ROADS & DRAINAGE CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

**AMENDMENT NO. 16 - 2023 CAPITAL IMPROVEMENTS - APRIL 2023**

**SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)**

**CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE**

Ochsner Blvd. Sidewalk - Property ID: R01E018

Scope: To build a six foot wide sidewalk from Bootlegger Rd. to the Connector Rd. tie-in at the Ochsner Blvd. Roundabout. The sidewalk will be approximately 4,100 feet long and run on the west side of Ochsner Blvd. This project is part of a Transportation Alternative Grant (TAP) Grant with the second part being a sidewalk that will tie into Bootlegger Rd. and run down Ochsner Blvd. This project will provide a safe route for pedestrians and bicyclists down Ochsner Blvd. and tie into the Connector Rd.'s mix used path and the sidewalk along Bootlegger Rd.

Status: This project is currently in the pre-design and budgeting phase. A vendor will have to be selected to complete the design requirements for the TAP Grant. Design should be finished by mid-year 2024 with construction beginning sometime late 2024. The Parish was awarded \$617,780.00 for this segment of the sidewalk to put towards construction. The Parish is required to pay for design and any additional construction funding required.

Bootlegger Rd. Sidewalk, Ph.2 - Property ID: R01C018

Scope: To build a six foot wide sidewalk from White Chapel Rd. to Francis Rd. The path will tie into existing sidewalks at White Chapel Rd. and Francis Rd. The sidewalk is approximately 4,800 feet long and will run along the north side of Bootlegger Rd. This project is part of the same TAP Grant as the Ochsner Rd. Sidewalk project. The project will complete a safe route for pedestrians and bicyclists from Coquille Park to Hwy 21.

Status: This project is currently in the pre-design and budgeting phase. A vendor will have to be selected to complete the design requirements for the TAP Grant. Design should be finished by mid-year 2024 with construction beginning sometime late 2024. The Parish was awarded \$617,780.00 for this segment of the sidewalk to put towards construction. The Parish is required to pay for design and any additional construction funding required.
