ORDINANCE TO OFFICIALLY NAME THE 20-FOOT ROAD IDENTIFIED ON THE ATTACHED SITE PLAN SUTER LANE (WARD 1, DISTRICT 1).

WHEREAS, a petition has been submitted to the Department of Planning & Development and forwarded to the Parish 911 Communications District signed by at least 50 percent plus one of the property owners owning or fronting the identified road has been submitted; and

WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the unnamed 20-foot access road. Pending Approved Name: Suter Lane, Nearest Cross-street: Thunderbird Drive, Covington, LA 70433. Since future structures will be addressed off the newly named road; the access will be added to the 911 Database and to the 911 Dispatch Map;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially name the 20' road identified on the attached site plan as Suter Lane.

REPEAL: ALL ordinances or part of ordinances herewith are hereby repealed.
