Materials of Opportunity

Scope: A budget increase is being requested for continued assistance and implementation of the Materials of Opportunity Initiative, which is to develop a program that would seek to repurpose various materials that would otherwise be discarded or underutilized. Services for the contract amendment will include Grant Writing, Grants Administration, Project Management & Monitoring, Communication & Coordination, and Problematic Implementation.

Status: Additional funds will provide for a continuation of services that will result in a definitive report needed to move forward with the project. The estimated time to complete this phase of work is 18 months.

Pearl River Navigational Canal Feasibility Study

Scope: Project goal is to demonstrate the need for removal of the sill on the Pearl River Navigational Canal. This will provide natural hydrology and ecosystem function, and reduce the risk of flooding. It will also reduce structural failure and dangers to public boat traffic. The study will also show that removing the sill will allow for recreational opportunities and public access by creating a 16-mile lake system next to federal and state-wildlife management areas. A proposed plan is in place to entomb Locks No. 1, 2, and 3, the surrounding land to be stabilized, and a siphon to be installed through Lock No. 2 to maintain water levels between Lock No. 1 and 2.

Status: Once approved, the estimated time for completion will be 18-24 months.

Tchefuncte West Bank Marsh Restoration

Scope: Project goal is to reclaim the land through either a marsh and/or beach restoration by dredging material within Lake Pontchartrain. The area of focus for this project is west of the Tchefuncte Lighthouse in Madisonville, LA. The requested budget increase will fund Phase 2 (Preliminary Design) and Phase 3 (Final Design). Phase 2 will allow for detailed engineering of the project with 60% and 90% design submittals. Phase 3 will address the comments received from the Parish and permitting agencies for the Preliminary Design Phase.

Status: The estimated additional time to complete these phases will be 12 months.
