Northwood Dr. Drainage - Property ID: D08IW02030

Scope: Remove and replace drainage by installing/replacing drain pipe, catch basin, and replacing concrete panels and curbs. Budget amendment requested to cover work that is needed and will be on change order #1. This work is required due to findings once construction began. Work will include additional bedding material, CB-02 catch basin, wooden fence, concrete pavement, concrete curb, and add contingency.

Status: A vendor is currently under contract. The project will be able to continue with the help of more funding. The target completion date for this project is June 23, 2023.
