ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 43

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE

South Slidell Levee Protection

Scope: This project will be for the design and construction of an earthen levee that will connect to the existing network of levees from the railroad tracks in west Slidell to Oak Harbor, then to the south of Slidell through the subdivisions Oak Harbor, Lakeshore Estates and Kingspoint, and ending at US190 in the east of Slidell to ultimately provide 100 year flood protection. Exact length and location of levee segment to be built is to be determined based on the Corp and CPRA's ongoing studies/designs of the Slidell levee system.

Status: This project is currently waiting for the Corp study to produce their tentatively selected plan before moving forward. The path this project takes will weigh heavily upon the outcomes of the Corp and CPRA's ongoing studies/designs of the Slidell levee system.
