ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 37
PARISHWIDE ROADS & DRAINAGE CAPITAL PROJECTS

CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE

Berry Todd Rd. Bridge

Scope: Project will remove and replace bridge approach slabs and guard rail.

Status: Estimate has been updated with recent bid data, which exceeds the previous estimate of \$150,000.00. Survey has been completed, and plans are being developed in-house and are estimated to be completed in July.

Rousseau Rd. Bridge

Scope: Project will conduct surveys, environmental studies, geotechnical analysis, and engineering design to construct a replacement structure for the Rousseau Rd. bridge. Right-of-way may be required and property acquisition services may be necessary to acquire property. Construction

Status: The existing bridge will need to be modified and shored during construction of the replacement bridge due to the proposed sequence of construction of the project. During preliminary plan development this past year, the condition of the bridge has deteriorated, so consideration is being given to now shore up the existing bridge prior to construction of the new bridge all while the right-of-way is acquired and final plans are developed. Preliminary plans have been completed and right-of-way map(s) are being developed for property acquisition. Once all environmental has been cleared, work on final plans will begin.
