St. Tammany Parish Artificial Reefs

Scope: St. Tammany Parish is requesting a professional services proposal for the installation of an artificial reef in Lake Pontchartrain. The reefs will act the first level of defense for the Big Branch Marsh National Wildlife Refuge and create an essential aquatic habitat. The second line of defense will be the Living Shorelines project. The reefs will create an essential aquatic habitat for aquatic species and protection for submerged vegetation and clam beds.

Status: Approval for funding to procure a vendor for design work to achieve the above subject is being requested at this time.
