RESOLUTION TO ACKNOWLEDGE ANNEXATION BY THE VILLAGE OF FOLSOM.

WHEREAS, on April 11, 2005, the Village of Folsom annexed a 10.00 acre residentiallyzoned parcel of land from St. Tammany Parish; and,

WHEREAS, the Parish of St. Tammany does not have a record of said annexation; and,

WHEREAS, the annexed parcel of land has been incorporated into the municipal boundaries of the Village of Folsom for taxing and voting purposes since 2005; and,

WHEREAS, for the completeness of records for the Parish and the Registrar of voters, St. Tammany Parish Government acknowledges the aforementioned annexation of the parcel described more particularly below.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES to acknowledge the annexation of an immovable 10.00 acre residentially-zone parcel of land by the Village of Folsom through its ordinance dated April 11, 2005, and filed with the St. Tammany Parish Clerk of Court as Instrument No. 1490055, attached hereto as Exhibit A, with the location described as:

From the Section Corner common to Sections 3, 4 and 9, Township 5 South, Range 10 East, St. Tammany Parish, Louisiana, go North 00 degrees 00 minutes 14 seconds East a distance of 25.0 feet to the point of beginning.

From the point of beginning, continue North 00 degrees 00 minutes 14 seconds East a distance of 656.32 feet to a point; thence go North 89 degrees 55 minutes 40 seconds East a distance of 663.71 feet to a point; thence go South 00 00 minutes 14 seconds West a distance of 656.32 feet to a point; thence go South 89 degrees 55 minutes 40 seconds West a distance of 663.71 feet to the point of beginning.

Containing 10.00 acres. All in accordance with process verbal of map and plat of survey by Land Surveying, Inc., Jeron R. Fitzmorris, registered land surveyor, dated March 2, 2005.
