ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 66
PARISHWIDE ROADS & DRAINAGE CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

AMENDMENT NO. 66 - 2023 CAPITAL IMPROVEMENTS - NOVEMBER 2023

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE

Moonraker Dr. Drainage

Scope: Project to include drainage improvements along approximately 1,700 feet of outfall pipes that drain the Moonraker Dr. right-of-way. Improvements to include cured-in-place drainage pipe lining and catch basin improvements. Many of the outfall pipes servicing the Moonraker Dr. right-of-way are made of metal and are deteriorating near the pipe ends, causing erosion issues in adjacent properties. All of the drainage servitudes are narrow and access to maintain these pipes is difficult. This project aims to alleviate the erosion issues noticed by many property owners adjacent to Parish-maintained outfall pipes along Moonraker Dr.

Status: Requested funds are for construction of the project. Residual funds from the Moonraker Dr. project will be utilized to fund the new drainage project. Construction anticipated to begin in Spring 2024 and is expected to take approximately two months to complete.
