AN ORDINANCE ACCEPTING FINALIZED SUBDIVISIONS INTO THE ROAD AND DRAINAGE INVENTORIES, SPECIFICALLY ARUNDEL SUBDIVISION, (WARD 1, DISTRICT 4)

WHEREAS, Developer/Owner(s) have dedicated the rights or ways to the public as indicated on the finalized subdivision plat recorded in the Clerk of Court’s office; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that all the area within the right-of-way, the road base, drainage ditches, culverts, laterals, canals and appurtenances belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolution/Ordinance stated shall be incorporated in the Parish Maintenance System.

BE IT FURTHER ORDAINED: that all parish regulations, policies, procedure, and operating methods pertain to the Parish Maintenance System shall apply to the aforementioned developments:

Streets to be accepted into the maintenance system are named:

- Wing Court (R01J102) approximately 325 feet
- Castle Oak Lane (R01J103) approximately 789 feet
- Castle Oak Lane pond (P01JW01103) 0.75 acre

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
