ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 52
COASTAL ENVIRONMENTAL CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter; and

WHEREAS, the Parish has identified additional capital improvements, capital assets, and/or grant-funded improvements for Fiscal Year 2023; and

WHEREAS, there are a number of vessels that have been abandoned in Parish waterways; and

WHEREAS, these vessels cause a hazard to people using these waterways and are an environmental concern because they are completely or partially submerged; and

WHEREAS, the necessary funding has been identified as unobligated in the GOMESA budget; and

WHEREAS, with this being a matter of public health, safety, and welfare, the project needs to start as soon as possible to prevent accidents and/or leakage of gasoline or other substances into the waterways.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the 2023 Capital Improvement Budget and Capital Assets List is amended as follows:
