WHEREAS, Parish desires to acquire the Property and authorize the Office of the Parish President to do whatever is necessary to enter into negotiations and acquire said Property.

TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, through the Office of the Parish President, is authorized to acquire by purchase, donation or otherwise, all or parts of the proposed parcels, rights-of-way and/or servitudes for certain parcels as depicted on the Sketch of Proposed Drainage Servitude (Sheets 1, 2 and 3) Located in Squares 93, 91, 87, 90, & 95, St. Tammany Hills Subdivision, Section 11, Township 7 South, Range 11 East, Greensburg Land District, St. Tammany Parish Louisiana by S. Brett Fitzgerald, P.L.S., J.V. Burkes & Associates, Inc. dated April 24, 2023, attached hereto (collectively, the "Property"); and			
BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in acquiring the Property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and			
BE IT FURTHER ORDAINED: that, if purchased, the purchase price shall not exceed the fair market value of the Property, plus closing costs and fees; and			
BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.
