ORDINANCE TO PARTIALLY REPEAL ORDINANCE NOS. 07-1590		
AND 07-1694, LEVYING AN ADDITIONAL SALES TAX IN THE		
ROOMS TO GO ST. TAMMANY ECONOMIC DEVELOPMENT		

WHEREAS, pursuant to LSA R.S. 33:9038.31, et seq., a sales tax of an additional three-quarters of one percent (0.75%) was levied in the Rooms to Go St. Tammany Economic Development District, State of Louisiana to provide a revenue source for functions benefitting economic development; and

DISTRICT, STATE OF LOUISIANA (WARD 8, DISTRICT 9)

WHEREAS, St. Tammany Parish and the Rooms to Go St. Tammany Economic Development District, State of Louisiana, now seek to repeal the levy of the additional three-quarters of one percent (0.75%) levied in the Rooms to Go St. Tammany Economic Development District, State of Louisiana as per Ordinance Nos. 07-1590 and 07-1694, both of which were codified in the Code of Ordinances as Sec. 120-289(b).

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that Ordinance Nos. 07-1590 and 07-1694, codified in the St. Tammany Parish Code of Ordinances as Sec. 120-289(b), are hereby partially repealed insofar as said Ordinance Nos. 07-1590 and 07-1694, codified in the St. Tammany Parish Code of Ordinances as Sec. 120-289(b), levy an additional three-quarters of one percent (0.75%) sales tax for economic development functions pursuant to LSA R.S. 33:9038.31, et seq.;

BE IT FURTHER ORDAINED: that in order to provide sufficient time for the St. Tammany Parish Sheriff to provide notices and for the retailers to retool their tax collection and remittance systems, the effective date and time of the repeal of the additional three-quarters on one percent (0.75%) sales tax levied by Ordinance Nos. 07-1590 and 07-1694, codified in the St. Tammany Parish Code of Ordinances as Sec. 120-289(b), shall be March 31, 2023 at 11:59pm;

BE IT FURTHER ORDAINED: that all other provisions of Ordinance Nos. 07-1590 and 07-1694, codified in the St. Tammany Parish Code of Ordinances as Sec. 120-289(b), shall remain in effect.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon adoption.

This Ordinance seeks to repeal/cancel the current 0.75% sales tax levied within the Rooms to Go St. Tammany Economic Development District, State of Louisiana. The effect being that this additional 0.75% sales tax will no longer be levied within this District.
