RESOLUTION APPROVING AND AUTHORIZING ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PRESIDENT, TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND THE CITY OF MANDEVILLE FOR THE PURPOSE OF DEVELOPING THE AMERICA STREET PARK PROJECT AS A PUBLIC SPACE IN THE CITY OF MANDEVILLE, PARISH OF ST. TAMMANY, LOUISIANA

WHEREAS, the St. Tammany Parish Government desires to promote the health, benefit and enjoyment of the City of Mandeville residents, Parish residents, Tammany Trace visitors, and the general public; and

WHEREAS, the St. Tammany Parish Government desires to enter into a Cooperative Endeavor Agreement with the City of Mandeville for the purpose of constructing a public access park owned by the City of Mandeville for use by City residents, Parish residents, Tammany Trace visitors, and the general public; and

WHEREAS, St. Tammany Parish Government desires to cooperate with the City of Mandeville in the development of the America Street Park Project by entering into an agreement to allow access within the right of way granted to the Parish for the City of Mandeville to perform maintenance on improvements or other constructions placed thereon by the City of Mandeville; and

WHEREAS, the St. Tammany Parish Government desires to agree to a scope of services with the City of Mandeville; and

WHEREAS, the Parish will permit the City of Mandeville to have certain exclusive right of way privileges on the Project site on the north side of America street, eastern side of Lafayette Street, either side of unconstructed Caroline Street, and within the Tammany Trace; and

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President of St. Tammany Parish is authorized to sign and/or execute a Cooperative Endeavor Agreement between St. Tammany Parish Government and the City of Mandeville and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein, and

FURTHER THAT, all acts previously taken by the Office of the Parish President in furtherance of the actions or agreement contemplated herein are hereby ratified and approved.
