Justice Center Boilers

Scope: The two (2) boilers at the Justice Center are over 20 years old, have outlived their useful service live, and are in need of replacement. Existing gas heat boilers are deteriorating internally and tubes are coming apart. Project is to procure boilers of the same specifications, remove old boilers, install (2) new boilers, and test for operations.

Status: Budget request is to secure funding for second boiler. Project is ready to go out for bid, with the designs in place and scope completed.
