Cedar St. Extension/LA22 Roundabout	Allocate available funds to participate with DOTD to design and construct a roundabout at the not yet constructed extension of Cedar St. and LA22. Total project budget is \$1,400,000.00 as follows: \$1,050,000.00 from Capital Projects fund 200-4640 - Sales Tax District 3 - Parishwide Roads & Drainage and \$350,000.00 from Facility Planning & Control (FP&C) - Capital Outlay.		
Lake Rd./Bridges	Property IDs: B07F103, B07F203, B07F303, R07F003; Allocate available funds to repair bridges and improve road surface along Lake Rd. to provide improved accessibility to the Big Branch Federal Wildlife Management Area. Project, originally budgeted in 2019, is being reinstated to reflect new cost estimates. Total project budget is \$515,240.00 as follows: \$250,000.00 from Capital Projects fund 200-4640 - Sales Tax District 3 - Parishwide Roads & Drainage and \$265,240.00 from the Federal Highway Administration (FHA) - Federal Lands Access Program Grant.
