-Tanner - 1. Ord. Cal. No. 7210 - Ordinance authorizing the Parish of St. Tammany, through the Office of the Parish President, to acquire certain parcels, rights-of-way and/or servitudes for debris storage and processing (Ward 8, District 9). (Smith/Cooper)

-Lorino – asked administration about appraisal or price.

-Holly Thomas – said she did not have it off-hand. She said they have to get acquisitions back.

-Lorino – asked how will it be paid.

-Leslie Long – explained that it will have to come to the Council.

-Lorino – asked why we need this.

-Thomas – answered and said it is for debris and ditch dirt.

-Toledano – asked about the use of this for storage of things for current drainage projects.

-Thomas – answered that this would help.

-Laughlin – asked if there is a reason why they have to haul off the ditch dirt because some of his constituents ask to keep it.

-Thomas – answered that it is because of legal issues and there is other stuff in the dirt.

-Toledano – moved to refer to the full Council, seconded by Smith. Unanimous with 2 absent (Cazaubon, Airey).

-Binder– moved to refer Ordinances for Introduction #2 through #12 to the Finance Committee, seconded by O’Brien. Unanimous with 2 absent (Cazaubon, Airey).

-Tanner - 2. Reso. C.S. No. C-6730 - Resolution to concur/not concur (circle one) with the City of Slidell annexation and rezoning of Lot 1-10, Sq 2 Central Park s/d, from Parish NC-1 & A-4a to City of Slidell C-4 Highway Commercial. Property is located near intersection of Spanish Court & Hwy 433, Slidell, LA, situated in Section 23, Township 9 South, Range 11 East. (Ward 8, District 12) (Airey/Cooper)

-Binder – explained that this annexation has to be an equal zoning classification to the Parish zoning classification. He said the City classification is more intense. He asked if the administration has determined if this is more intense?

-Emily Couvillion – answered that it would be an intensification of the residential portion as stated in the annexation resolution, but she would look more closely.

-Binder – moved to refer to the full Council, seconded by O’Brien. Unanimous with 2 absent (Cazaubon, Airey).

-O’Brien – moved to refer the remainder of the agenda less items pulled to the full Council, seconded by Smith. Unanimous with 2 absent (O’Brien, Airey).
