ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 5
PARISHWIDE ROADS & DRAINAGE CAPITAL PROJECTS

WHEREAS, St. Tammany Parish Government has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

WHEREAS, St. Tammany Parish Government has identified additional capital improvements, capital assets, and/or grant-funded improvements for Fiscal Year 2023.

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE

Stone Rd.-Powell Dr.

Scope: Stone Rd. to Powell Dr. is a project to build a new road to divert industrial traffic from Ben Thomas Rd. to Powell Dr. in order to utilize proposed future improvements to the intersection of Powell Dr. and US11. Ben Thomas Rd. is a mostly residential area with high pedestrian traffic and is not built to handle frequent industrial sized loads. The project will include a new roadway starting at the intersection of Stone Rd. and Ben Thomas Rd., and extending north to Powell Dr. The existing Powell Dr. will be improved to provide a safe route for industrial and residential traffic and pedestrians.

Status: A vendor is currently under contract through final design, which is expected in late 2023. The Parish has been awarded \$500,000.00 by Capital Outlay to put towards construction of the project, which is estimated to cost over \$3.6 million to construct.
