**SECTION II: CAPITAL IMPROVEMENTS - FACILITIES**

**CAPITAL PROJECTS - 249-2412 - SAFE HAVEN COMPLEX**

Safe Haven Quad A Renovation-Suite 101, 102, 104

Scope: The project will renovate the existing portions of Quad A that have not been renovated in prior projects (Safe Haven Renovation and Quad A Suite 105). This renovation is approximately 11,391 square feet to include first responder offices, expand the footprint of adult crisis services, and create a teen/adolescent crisis service space. The purpose of the project is to house all mental health crisis services in one building which includes the crisis line (Suite 105), first responders (Suite 101) and crisis treatment services (Suites 102-104).

Status: Once approved, the estimated time for completion will be 18 - 24 months. This will meet the ARPA funding deadlines.
