RESOLUTION SUPPORTING AND AUTHORIZING ST. TAMMANY PARISH  
GOVERNMENT TO AMEND CONTRACT FOR LEGAL SERVICES TO INCLUDE  
GENERAL LABOR AND EMPLOYMENT LAW MATTERS.

WHEREAS, St. Tammany Parish Government is committed to creating a safe workplace for all employees and complying with all federal, state, and local laws related to employment matters; and

WHEREAS, Rabalais Unland, LLP is a local law firm specializing in workers' compensation, labor and employment law, general liability, as well as numerous other practice areas; and

WHEREAS, the St. Tammany Parish Council has previously authorized the retention of Rabalais Unland, LLP as special counsel to represent the St. Tammany Parish Government in workers' compensation matters; and

WHEREAS, Matthew Crumhorn, Esq., a partner at Rabalais Unland, LLP, specializes in labor and employment law, as well as workers' compensation, and has no conflicts which would prohibit him from representing St. Tammany Parish Government in these matters; and

WHEREAS, St. Tammany Parish Government has determined it to be in its best interest to extend its engagement with Matthew Crumhorn, Esq., and Rabalais Unland, LLP, to include legal services related to general labor and employment law matters; and

WHEREAS, St. Tammany Parish Government desires to authorize the amendment and execution of the Contract for Legal Services attached and identified as Exhibit "A," to include legal services for general labor and employment law matters.

THE PARISH COUNCIL OF ST. TAMMANY HEREBY RESOLVES that Parish President Michael B. Cooper is authorized to amend and execute the Contract for Legal Services Agreement with Rabalais Unland, LLP based upon the terms and conditions set forth herein and, in a manner, substantially similar to the Agreement attached hereto as Exhibit "A," to include legal services for general labor and employment law matters.
