ORDINANCE TO OFFICIALLY RENAME THE 50-FOOT RIGHT-OF-WAY
IDENTIFIED ON THE ATTACHED SURVEY FROM DELTA STREET TO
LOIS LANE (WARD 3, DISTRICT 2)

WHEREAS, a petition has been submitted to the Department of Planning & Development and forwarded to the Parish 911 Communications District signed by at least 50 percent plus one of the property owners owning or fronting the identified road has been submitted; and

WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the 50-foot private road currently named DELTA STREET. Pending Approved Name: LOIS LANE, Nearest Cross-street: ELDORA AVENUE, COVINGTON, LA 70433. Since future structures will be addressed off the newly named road; the access will be added to the 911 Database and to the 911 Dispatch Map;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially rename the 50-foot right-of-way identified on the attached survey from DELTA STREET to LOIS LANE.

REPEAL: ALL ordinances or part of ordinances herewith are hereby repealed.

SEVERABILITY: if any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
