RESOLUTION TO VACATE, IN PART, THE MORATORIUM ORIGINALLY ESTABLISHED BY ORDINANCE COUNCIL SERIES NO. 24-5408 ON THE ISSUANCE OF PERMITS FOR CONSTRUCTION OR PLACEMENT OF BUILDING STRUCTURES ON ANY PROPERTIES WITHIN THE FOREST GLEN SUBDIVISION LOCATED IN COUNCIL DISTRICT 7, SPECIFICALLY LOT 3-A IN THE FOREST GLEN SUBDIVISION, ALSO BEARING THE MUNICIPAL ADDRESS OF 25685 W. CHESTNUT AVENUE. (IMPASTATO)

WHEREAS, on April 04, 2024, the Parish Council adopted Ordinance Council Series No. 24-5408, an ordinance establishing a six (6) month moratorium on the issuance of permits for the construction or placement of building structures on any properties within the Forest Glen Subdivision located in Council District 7; and

WHEREAS, it was determined that a moratorium is needed to protect and preserve the health, safety, and property interests of residents from the emergent situation pertaining to water utility systems in the area; and

WHEREAS, the owner of Lot 3-A in the Forest Glen Subdivision, bearing the municipal address of 25685 W. Chestnut Avenue as shown on the attachment has requested that the moratorium be lifted; and

WHEREAS, it has been determined that the lifting of the moratorium on the abovementioned property would not contribute to the adverse effects of traffic and flooding hazards.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that pursuant to Chapter 2, Article XVI, Sec 2-264 of the Code of Ordinances, the Parish Council vacates, in part, the moratorium established by Ordinance Council Series No. 24-5408, and any subsequent extension thereof, to remove therefrom the restriction on the issuance of permits for the construction or placement of building structures on Lot 3-A in the Forest Glen Subdivision, also bearing the municipal address of 25685 W. Chestnut Avenue.
