ORDINANCE TO AMEND THE 2024 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 13

Scope: Add a turn lane by widening Bigner Rd. at the LA22 approach. Project involves altering drainage structures and the sidewalk at the intersection.
