ORDINANCE TO AMEND THE 2024 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 12

**CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE**

Old River Rd.

Scope: Old River Rd. was identified by Engineering in 2019 as requiring pavement condition improvements. Project will perform 2" Mill, 2" overlay, full depth patching, reconstruct areas, and striping of Old River Rd. in Slidell, LA.

Status: This project was placed on hold while another project studying the proposed raising of Old River Rd. (Old River Rd. Raising) and Bridge Improvements (Old River Rd. Bridge) could be completed so that the repaving of Old River Rd. would coincide with the bridge and road raising improvements. The study and bridge repairs were completed in 2023 and construction is now proposed to take place in 2024.
