ORDINANCE ACCEPTING FINALIZED SUBDIVISIONS INTO THE ROAD AND DRAINAGE INVENTORIES, VERSAILLES BUSINESS PARK, PH. 2 (WARD 3, DISTRICT 5) COUNCIL SERIES RES. NO.: C-6893

WHEREAS, Developer/Owner(s) have dedicated the rights or ways to the public as indicate on the finalized subdivision plat recorded in the Clerk of Court’s office; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that all the area within the right-of-way, the road base, drainage ditches, culverts, laterals, canals and appurtenances belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolution/Ordinance stated shall be incorporated in the Parish Maintenance System.

BE IT FURTHER ORDAINED: that all parish regulations, policies, procedure, and operating methods pertain to the Parish Maintenance System shall apply to the aforementioned developments:

Versailles Business Parkway (R03A043) for approximately 800 ft.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
