**Amendment No. 4 - 2024 Operating Budget - March 2024**

**This budget amendment is to:**

a. **112 - ANIMAL SERVICES FUND**

**FUNDING SOURCE: AD VALOREM TAXES AND ANIMAL SERVICE FEES**

1) To amend the revenue and expenditure budget for a donation from Netchex of \$20,000, dedicated to replacing the doors in the kennel runs, purchasing Kuranda beds for the dogs in the kennels, and any other animal care items needed.

2) To amend the expenditure budget for \$81,000 to convert 3 part-time Animal Care Technician positions to full-time.
