I have been actively involved with the Junior Rodeo for more than 25 years and, more recently, with the Bull-A-Rama. Our goal is to provide a safe, well-organized, and memorable event that the Sumas community can continue to take pride in.

All proceeds from the Bull-A-Rama directly support the Sumas Junior Rodeo. This longstanding commitment helps sustain and strengthen our youth rodeo program and ensures its continued success for future participants.

As part of the event, the Bull-A-Rama has traditionally included a beer garden. We have implemented several improvements to ensure the beer garden remains secure, appropriately contained, and separate from family-oriented activities.
