## RESOLUTION 848

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUMAS, WASHINGTON, ADOPTING THE SIX (6) YEAR TRANSPORTATION IMPROVEMENT PROGRAM FOR THE YEARS 2026 THROUGH 2031.**

**WHEREAS**, pursuant to the requirements of Chapter 35.77 RCW, the City of Sumas, Washington, prepared a Comprehensive Street Program, herein referred to as the City's Transportation Improvement Program, for the ensuing six (6) years; and

**WHEREAS**, pursuant to RCW 35.77.010(1), the City Council of the City of Sumas, being the legislative body of said City, did hold a duly advertised public hearing on said Transportation Improvement Program at 7:00pm, at the City Hall in the City of Sumas, Washington on 23rd day of June 2025; and

**WHEREAS**, there were no written or oral objections to the Transportation Improvement Program, as considered by the City Council of the City of Sumas; now, therefore,

**THE CITY COUNCIL OF THE CITY OF SUMAS, WASHINGTON, HEREBY RESOLVES as follows:**

**SECTION 1.** That the Six (6) Year Transportation Improvement Program for the six-year period 2026 through 2031, a copy of which is attached hereto as **Exhibit A** and incorporated by this reference as if fully set forth herein, be and the same is hereby adopted as the Comprehensive Street Program required by RCW 35.77.010.

**SECTION 2.** That the Clerk forward a copy of this Resolution, together with all attachments thereto and necessary forms to the director of Highways of the State of Washington and the planning manager of the Whatcom Council of Governments within thirty (30) days of the date of passage.
