FIREWORKS APPLICATION



Please follow State Statutes, which are RCW Chapter 70.77.

4.64.010 Adoption of state statutes.

The sale of fireworks within the city of Sumas shall be governed by RCW Chapter 70.77, which statute is adopted by the city. (Ord. 832 § 1, 1982)

4.64.020 License to sell fireworks.

- (a) The sale of fireworks within the city shall be limited to the following: bona fide charitable organizations.
- (b) Any charitable organization which desires to sell fireworks within Sumas shall make written application to the city council and such application shall be in the form as provided by the city clerk-treasurer and shall be accompanied by an annual license fee of twenty-five dollars. No license to sell fireworks shall be granted unless the application as provided is approved at the regular city council meeting.
- (c) Applications under this chapter to sell fireworks must be made annually. (Ord. 832 § 2, 1982)

State Statute-

RCW 70.77.395 Dates and times consumer fireworks may be sold or discharged—Local governments may limit, prohibit sale or discharge of fireworks. (1) It is legal to sell and purchase consumer fireworks within this state from twelve o'clock noon to eleven o'clock p.m. on the twenty-eighth of June, from nine o'clock a.m. to eleven o'clock p.m. on each day from the twenty-ninth of June through the fourth of July, from nine o'clock a.m. to nine o'clock p.m. on the fifth of July, from twelve o'clock noon to eleven o'clock p.m. on each day from the twenty-seventh of December through the thirty-first of December of each year, and as provided in RCW 70.77.311.
