Notable Incidents

Just before 3pm on Saturday, April 20 the Amador Dispatch center received a 911 call from cell phone with no service, and no associated phone number. The caller told the 911 dispatcher she had been walking home from Amador High School when she was hit in the head and knocked unconscious by an unknown assailant and was now locked in a room at an unknown location. The caller stated someone was coming and disconnected the call. With no phone number associated with the call, dispatchers were unable to call the phone back.

Sutter Creek Police officers began an intensive search of the area for the caller or any investigative leads. Officers conducted a thorough search of the school campus and began a door-to-door neighborhood canvass. At the same time, additional SCPD officers were trying to obtain any information available through cell phone records. Officers were able to determine the call was placed via a local cell tower. With assistance from the Amador DA's Office and the FBI, Sutter Creek Police Officers were able to determine a unique identifier of the cell phone used to make the 911 call, and an associated person.

Sutter Creek Officers responded to the address of the identified subject and made contact with an 8-year-old child who has admitted to making the 911 call. The child was never in any danger and has been counselled on reporting false emergencies.


Downtown Foot Patrol

Community Outreach


Officer McKeon was asked by Amador High School to lead a conversation with creative writing students.
