### Recommendation:

Approve the resolution awarding the construction contract for the Eureka Road Overlay Project to the low bidder.

### Background:

The City prepared a Project Study Report (PSR) for Eureka Road in October 2023 to the Amador County Transportation Commission (ACTC) for roadway rehabilitation funding. On January 22, 2024 John Gedney of ACTC notified the City that construction funding was approved for a maximum amount of \$405,000 as identified in the PSR.

Due to escalating construction costs in recent years, the project was broken out into a base bid with an additive alternate. The base bid project consisted of drainage improvements and an asphalt concrete overlay. Additive Alternate #1 consisted of installing a paving grid underneath the asphalt concrete overlay to provide additional roadway strength and increase the life of the asphalt concrete.

### Discussion:

The City of Sutter Creek conducted the bid opening for the Eureka Road Overlay Project at 10:00 a.m. on May 8, 2024. The City received five bids for the project as follows:

Based upon the attached bid summary, I hereby recommend the City Council of the City of Sutter Creek award the contract for the Base Bid and Additive Alternate #1 to the low bidder, Consolidated Engineering, Inc. in the amount of \$255,877.00. Construction is anticipated to start on/around June 17<sup>th</sup> and end on/around July 26<sup>th</sup>.
