Executive Summary

At the May 21, 2024 meeting, proposals were presented from the 2nd run of the Janitorial Services RFP. Council requested for the services to stay as is, on a month to month basis with the City's current janitorial provider. Council additionally requested for a generalized agenda item to be brought back to the next regular meeting to further discuss janitorial rates and fees.

The City supplies all janitorial supplies to be used by the janitorial provider for all buildings.

- Seniors Building- We do not charge to use. Actions occupy the building Monday Friday, 8am- 12 noon.
 - Ten (10) additional groups are currently using the facility.
 - o The building is cleaned twice a week.
- <u>Library</u>- The City provides janitorial services five days a week.
- <u>Community Center</u>- The Community Center is cleaned per rental. The renter is charged a \$90.00 cleaning fee. That fee is passed through to the janitorial services provider.
 - From FY (10/1) to May 31/24, the City has paid our janitorial provider \$2,340.00 for rental cleanings at the Community Center.
- * Staff suggests looking at incorporating a part time janitorial position to include all city buildings within the newly adopted FY 25 budget. A part time position could not exceed 1,000 hours. This would allow up to 20 hours per week for five facilities (CC, Seniors, Library, City Hall, Public Works, & Police Department), contrary to the currently three buildings cleaned for close to the same amount as projected if RFP requested rates are granted.

Community Center \$100.00 per cleaning/cleaned as rented
