## **Executive Summary**

Request received for city owned property usage for proposed farmers market by Sweeny Beautification. This would allow for vendors to sell on city property.

Date and times will need to be determined. If the event is longer than two hours, a restroom and hand sinks must be available. August 3<sup>rd</sup> is already designated for the Lions Club event and could not be utilized.

The City of Sweeny does not have a health inspector, we utilize the Brazoria County Environmental Health Department under an inter-local agreement. Proposed market would have to comply with Brazoria County's requirements, City ordinances, and state statutes. If approved, all vendors on city property are required to complete an indemnity/ hold harmless form. The City does require permits for temperature related roadside vendors/peddlers as well as any types of mobile food units.

Additional information below received from the Environmental Health Department for compliance.

- We consider the following "farm" produced items: Cottage Food Baked goods, canned items and jellies; fresh, whole produce or fruits; fresh herb/plants; yard eggs (if refrigerated); and we allow coffee sales (when using a safe water supply). 51% of the sellers should be of this type.
- Food Trucks, Jewelry and Clothes <u>are not</u> considered meeting this rule as those are more "craft" items.
- There should be a restroom and hand sinks available, for all events held longer than 2 hours.
- We just permit the establishments that will be selling to the general public. People selling whole
  fresh fruits and vegetables and those operating under the cottage food law are not required to
  have a permit to sell no matter where they choose to. But the municipality could enforce a
  "vendor/peddler" permit separate from the food permit.
