- a) Information Only Pacific Power Resiliency Grant for WTP Generator
   Engineer Technician Trish Rice gave a status update on the grant for the Water Treatment Plant generator.
- b) Request for Council Action Downtown Streetscape and Parking Plan Final Adoption Community and Economic Development Director Blair Larsen presented the Streetscape Plan and stated this will be the final report. CEDD Larsen stated formal adoption is necessary for finding potential funding sources.

a) Presentation and Request for Council Action – Council of Governments Recruitment Services IGA

d) Request for Council Action – Resolution No. 8 for 2022 – Intent to Appoint a City Manager City Manager Pro Tem Christy Wurster stated the Resolution presented is required as per City Charter. The Resolution declares the City Manager position vacant and states Council's intent to hire a City Manager.

e) Request for Council Action - ODOT US 20/OR 228 ADA Ramp Easement Offer Packet

Engineer Technician Trish Rice presented the agreement from ODOT to purchase 133 square feet of ROW for ADA ramp construction for the amount of \$2100. There was a question by Council if the offer was fair. Engineer Technician Rice explained an appraisal was completed by an independent party and \$2100 was the estimated value.

f) Request for Council Action - Community Services Consortium Water Assistance Contract

Finance Director Brandon Neish reported the State of Oregon designated \$13.8 million statewide to assist with water bills for those with low income.

The program is managed by the Community Services Consortium. The City would share specific utility account information after receiving a signed consent from customers to determine eligibility for the federal program.

City Manager Pro Tem Christy Wurster acknowledged and thanked Councilor Sanchez for her efforts to make this program available to Sweet Home residents.

Motion made to approve the agreement with Community Services Consortium for Water Assistance to residents by Councilor Sanchez, Seconded by Councilor Richards. Voting Yea: President Pro Tem Gerson, Councilor Trask, Councilor Coleman, Councilor Sanchez, Councilor Richards

g) Request for Council Action – Resolution No. 9 for 2022 – Surplus Equipment in Police and Public Works

Finance Director Brandon Neish reported there were items which were deemed no longer useful to the City and staff is requesting authorization to surplus those items.
