Work Session - Transportation System Plan

a) TSP Presentation

Garth Appanaitis provided an overview of the purposes behind updating the Transportation System Plan (TSP) and creating the North Sweet Home Area (NSHA) Plan. He noted that a TSP was required by State law and serves as the transportation element of the City's Comprehensive Plan.

He reviewed the draft goals related to transportation:

- Mobility, accessibility, and connectivity
- Safety
- Quality of life
- Economic development
- System management and maintenance

He reviewed identified needs in the following categories:

- Pedestrian
- Bicycle
- Safety
- Traffic
- North Sweet Home Area

He reviewed next steps including additional meetings with City Council adoption intended in February 2025.

Councilor Sanchez asked of the intended length of validity for the plan as proposed. Mr. Appanaitis stated that plans were designed to be valid for 20 years but some revisions may be necessary prior to 2045. Councilor Sanchez asked of the likelihood of the Oregon Department of Transportation (ODOT) agreeing to modify the Pleasant Valley and Highway 20 intersection based on the proposed plan. Mr. Appanaitis replied that the plan identified needs at the intersection but all final decisions would require ODOT approval and for the City to secure funding.

Planning Commission Vice Chair Melcher asked of the intent behind roundabouts. Mr. Appanaitis replied that when crashes do occur in a roundabout, they are typically at a lower speed and result in less serious outcomes. He added that in the correct traffic conditions, roundabouts were more efficient for drivers than other traffic controls.

Councilor Gourley asked if bicycle needs included an analysis of school locations which may have greater need for safe bicycle routes. Mr. Appanaitis replied that he had received that feedback in a prior session and that the maps presented were based on existing bike facility conditions rather than the surrounding area, but that the City had the discretion to prioritize projects based on other factors.

Adjournment

There being no further discussion, the meeting was adjourned at 6:11 PM.
