## **Recognition of Visitors and Hearing of Petitions:**

City Manager Kelcey Young recognized Cindi Robeck for going above and beyond in her duties as well as taking on additional duties. Cindi has been instrumental in all areas of finance at every level. She has worked during holidays and almost every weekend. She has provided oversight and institutional history in so many areas. She has provided excellent service with positivity while leading her own team. Cindi was awarded with a City of Sweet Home Challenge Coin.

Vince Adams spoke to show support for the three ordinance that are about to be adopted. Mr. Adams also spoke about the dangers of wrong way parking on streets and avenues in residential areas. He also had concerns of vehicles parked blocking sidewalks.

#### **New Business:**

a) PUBLIC HEARING: Resolution No. 1 for 2023 - A Resolution Adopting a Supplemental Budget for FY 22/23

The Public Hearing was opened at 6:39 PM.

Mayor Coleman asked if any of the Council had any exparte, personal bias and conflict of interest. There was none.

City Manager Young presented a staff report. City Manager Young highlighted key points stating the New Supplemental Budget is for \$40.60 Million which is a decrease of \$1.58 Million from the FY 21/22 Budget.. Changes include the overall organizational structure, fewer funds and accounts, and transfers have been completed.

The additions being requested are for a new police officer position, small amount for abatements, capital improvement for the police station, and capital improvement for ADA access at City Hall.

CM Young highlighted the reserves which total \$18,615,000.

Interim Finance Director Matt Brown explained the Supplemental Budget in depth. Each fund was reviewed, along with each department. ORS standards were reviewed, personnel services, material services, and capital outlay were combined into "operations".

Public Comment. There was none.

The Public Hearing was closed at 7:17 PM.

Mayor Coleman thanked staff for providing the summary and the budget which is transparent.

b) Department Head Presentation Reports

Each Department Head gave a quick overview of the 2022 year in review.

The Library discussed programs including the Summer Reading Program, Story Time, My First Library Card, 1000 Books Before Kindergarten and so many more. Volunteer hours exceeded 528 hours. 606 new library cards were issued during 2022. Challenges the Library is facing includes the need for additional space and staffing.

Chief Ogden presented the 2022 overview of the police department. the police department had a challenging year with staffing needs. Chief Ogden noted the efforts of the community that added to the department's success. The department responded for 9,600 call for service during 2022. Chief Ogden reported there are still two officer positions open. Six officers were hired last year. There were three Life Saving Awards presented. A new Chief of Police was hired. The department also was able to solve an armed robbery in less than 18 hours.

City Manager Kelcey Young presented the Public Works report for Public Works Director Springman who was not in attendance. Some of the highlights were the finalizing of the Water and Stormwater Master Plans, the Small Diameter Water Main Replacement Project, and the Water Treatment Plant Project. Other department project included the Water Meter Modernization project. The Northside Dog park is open and operational. Many of the FAC facility improvements are also credited to Public Works Staff.

Community and Economic Development Director Larsen presented the 2022 year end report his department. Each part of the department was highlighted, Planning, Building, Engineering, Code Compliance and Economic Development. Department staff was introduced. Some of the highlights included the adoption of a Streetscape Plan, a new Development Code, and the sale of the Willamette/Weyerhaeuser Mill site. Grand funded projects included the Streetscape Plan, Sankey Park, Housing Needs Analysis, Transportation System Plan and Park System Master Plan. In 2022 there were 36 single family homes built which is the highest in five years.

City Manager Young presented the Executive Department report which highlighted staff tenure and awards in 2022. There were 9 employees that completed their first year of service, 2 employees were recognized for 5 years of service, 4 employees for 10 years of service, and one employee recognized for 20 years of service. CSO Sean Morgan received the police employee of the year award for 2022. Three officers were presented with Lifesaving Awards, which speak to the talent and dedication of our officers.

c) Request for Council Action – Security Services Contract for FAC

Community and Economic Development Director Blair Larsen reported as part of the MOU with the FAC, the City agreed to take on security for night time. An Request for Proposal was published and a bid was received from NightHawk Security. There were two proposals. One was for the FAC Facility only, the other included a patrol car for additional security such as the old city hall facility.

Motion made to approve the contract with NightHawk Security for only the FAC facility by Councilor Richards, Seconded by Councilor Trask.

City Attorney Snyder explained the reason for the updates to SHMC 3.08.070. Language was clarified for future clean up of all public properties that allow the discard items of no value without notice as per state law.

Mayor Coleman reported she received a tour of the FAC facility and is grateful for Sweet Home's Police Department and Public Works. Mayor Coleman specifically thanked CSO Sean Morgan, Public Works Superintendent Dominic Valloni, and the Ad Hoc Committee on Health. She also thanked Councilor Sanchez who volunteers on the FAC Board of Directors. Mayor Coleman appreciated the compassionately responsible approach. It was noted 80% of the clients have traumatic brain injuries and have very specific needs.

City Manager's Report

City Manager Young reported she attended graduation for three of our Police Officers.

The FAC facility is currently open and at capacity with 21 huts filled. There is an overflow area at the Police Station. The former City Hall has been cleaned up.

There was discussion to move the council training to Feb 23rd and 24th.

Community and Economic Development Director Blair Larsen gave an update on the Ameresco LED Street Light Conversion.
