#### **Recognition of Visitors and Hearing of Petitions:**

Dave VanDerlip, Courtney Creek Drive, spoke to the Council regarding the mask mandate stating the hospitals are overflowing with COVID patients who are there because they refuse to wear masks, making it difficult for anyone else to access needed health care. The anit-mask movement is killing people.

Lori Martin, 37675 Sunset Lane, spoke against the mask mandate stating it is a mandate not a law, but it is a freedom of choice. Ms. Martin stated that the "unvaccinated" numbers in the hospitals are skewed.

Pam Darling, 39862 Misty Lane, encouraged the City Council to work together, especially in this time. Ms. Darling also spoke regarding the mask and vaccination mandate stating she believes in individual choice.
