## **Old Business:**

a) Request for Council Action - Willow/Yucca Street Neighborhood Local Improvement District (LID)

Community and Economic Development Director Blair Larsen gave a history regarding the Local Improvement District (LID) on Willow Street. The LID came to staff as a petition from residents of the Willow/Yucca Street neighborhood to extend City water infrastructure and service to the neighborhood, construct sidewalks, and street improvements. As per SHMC 3.16, three unbiased members of the public volunteered and investigated the LID. They made their recommendation of methodology in a Viewer's Report per SHMC. Public meetings were held on April 20 and April 29. An additional public meeting was held during a city council meeting. CEDD Larsen provided maps and updated estimated costs that proposed \$300,000 be paid by the City. CEDD Larsen explained without a cost share from the City, the cost would be excessive to the homeowners.

There was a time for questions of staff from the Council. Staff Engineer Joe Graybill gave a history on the property which was annexed in 1977.

Kari Jones,1877 Yucca Street, was opposed to the LID. She noted there would be additional cost to homeowners not included in the LID.

Carmen Espinosa, 2009 18th Avenue, was also opposed to the LID. She noted the area is populated by many elderly and low income families who cannot afford to live elsewhere, nor can they afford any additional payment. Mrs. Espinosa did agree that water is needed in the area.

David Jones, 1803 Yucca Street, stated he has never had an issue with his well or septic. He understands the needs for hydrants, especially due to the closeness of neighboring manufacture homes. He is opposed to the LID.

Josh Victor, 4404 Wiley Creek, spoke regarding the dry wells, noting he pumps water to many of the neighbors because their wells have gone dry. He spoke to the advantages of having streets and sidewalks. Mr. Victor was in favor of the LID. Mr Victor stated he owns many of the properties in the area and has forfeited any city contribution to his properties so that the cost would be less for the surrounding neighbors.

James Mellein ,1805 Willow Street, thanked the Council and staff for coming back with a more reasonable approach. He also thanked Josh Victor for being willing to bear a third of the LID cost. He stated the area is without paved streets and sidewalks. He spoke of the difficulty of elderly or disabled traversing the roads which are gravel. He stated this is a

livability issue. He reminded the Council the neighborhood has asked for the LID via petition. He encouraged the Council to consider the LID, locking in the construction cost now, with the third of the cost being born by a developer.

Council discussion ensued regarding the differences between a loan versus a bond.

Douglas Henthmon (online participant) 2000 18th Avenue was against the LID. His opinion was that the City should pay for the entire project or not do it at all.

Rebuttal: Carmen Espinosa stated there is a water need, but sidewalks can wait. She is willing to pay for water that is necessary for life.

Josh Victor spoke regarding a LID on Vine street that opted water only and noted there are still no sidewalks. He encouraged the project to be completed in full for livability.

Kari Jones spoke to livability and her opinion was that sidewalks and streets won't help the neighbor with the older manufacturing homes coming in.

Motion to direct staff to proceed with the preparing the ordinance for the LID as currently proposed made by Councilor Trask, Seconded by Councilor Gourley.

The Public Hearing was opened at 8:33pm.

Mayor Mahler asked of the Council if there were any Personal Bias, ExParte Information, or Conflict of Interest. There were none.

Staff Report: Finance Director Neish gave a history of the budget process and the Budget Committee meetings, included the Budget Committee adoption of the presented budget. The Public Hearing for adoption will follow on June 22, 2021. The required LBI notice was posted in the New Era May 19, 2021 and May 26, 2021.

Councilor Gourley recommend the marijuana money go to the housing needs for the homeless and any remainder put into the General Fund. There was discussion on the marijuana money and how it could be used.

Public Comment: None

The Public Hearing was closed at 8:55 pm.

Motion to make a priority to add expenditure authority to spend \$50,000 of the marijuana funds to the homelessness issue and return to the Council for any additional funds. Motion made by Councilor Gourley, Seconded by Councilor Richards.
