Sankey Park Project Update

Valloni gave an update of the work being done.

Valloni reported that the logging is complete. They are hauling the logs out, and the slash will be burned at an appropriate time.

Sankey Park Public Input/Gathering

Chairman Shreves gave an overview of the events. Associate Planner Clegg asked for volunteers from the Committee members.

Dog Parks/City Hall Park Proposal

Associate Planner Clegg introduced the proposal to the Committee. Public Works Operations Manager Valloni stated that the Public Works department is short handed, but would be ok with the opportunity. There was discussion regarding the prep work and maintenance that would need to be done at City Hall and at Northside Park for the dog parks. Dalton stated that the dog parks add value to the area, and they could start out with basic accessories.

The Committee expressed concerns about a playground at Clover Park. There is limited parking and it is a dangerous intersection. There was discussion about Clover Park being a small neighborhood park similar to Ashbrook park. Community and Economic Department Director Larsen will touch base with the staff engineer about a bulb out with ODOT. Valloni feels that the southwest corner of Clover Park would be the ideal location for a small playground.

The Committee voted to recommend to City Council a dog park at City Hall, a small playground at City Hall, a dog park at Northside Park, and the recommendation to move the proposed Clover

Park playground to Strawberry Park.

Motion to recommend the above to City Council made by Dalton, Seconded by Patton.

Weddle Bridge

Public Works Director Springman discussed the need to give Weddle Bridge a facelift. There are dedicated funds for the bridge, but additional funds will need to be sought to complete the job. Dalton states that he will reach out to the covered bridge society. The Committee will reach out to the Community for funding, labor and/or materials. It was recommended to put the current funding toward an inspection. It was discussed to involve the New Era with advertising and allocating the fees collected for renting Weddle Bridge towards a maintenance fund.

Associate Planner Clegg asked if the Committee would like to go back to monthly meetings. There are enough projects going on to justify the additional meetings.
