3. Proposed Draft Code Revisions.

City Planner Malissa Paulsen presented. Sight standard for trees and specific burden on building or city. We have to decide what standard we want to set, it is never less than 100ft and decide if we want a bigger buffer that 150ft. Overall average of 200ft, Tenino already has an environmental standard. Chair Rounsley stated he is leaning towards the 150ft. Ecology is pushing to put a timeline of 5yrs, after that it is up to the city.

Adding: Tree Hazard language, Emergencies or exceptions, mostly public utilities which encompasses private utilities as well. If they are going to add any update they have to follow process.

Planner Paulsen addressed the Flood Hazard area draft code. Until we adopt we are not in compliance. Once we adopt it will be on the agenda to push forward. We need to have laid out in our municipal code.

Chair Carney stated there was concern with the zoning of the Food Bank but the map looked like it was zoned for Commercial. Planner Paulsen confirmed it is zoned Commercial.
