Building Permit Fees

- **All Inclusive Building Permit Fee**
 - \$10 per \$1,000 of cost of Construction. Minimum All-Inclusive Building Permit Fee is \$40.00
 - Cost of construction shall be the greater of the actual cost of materials and construction or calculated at the rate of \$90.00/sq. Ft. for conditioned areas, \$60.00/sq.ft. for unconditioned areas under roof (garages, porches, and decks with roofs (whether screen or not)) and \$45.00/sq. Ft for other unconditioned areas such as decks , above grade patios, etc. In addition to the above fee, all costs for outside services required by the Town of Thunderbolt for plan review, construction inspections and/or resolutions, etc. shall be added to the cost of any permit and shall be payable either at the time of permit issue or upon issuance of a Certificate of Occupancy/Completion.
- **All-Inclusive Building Permit Application Review Fee**
 - **Residential**
 - New Construction- \$250.00
 - Major Modifications and/or Additions- \$75.00
 - **Commercial**
 - New Construction- \$400.00
 - Major Modifications and/or Additions- \$150.00
 - The cost of the above permit review fees will be deducted from the cost of the permit fee
- **Miscellaneous Work**
 - The following fees shall be calculated at \$8 per \$1,000 of cost of materials and construction or at the minimum fee stated below for all miscellaneous work described below. The fees shall be charged at the time of permit application and shall cover the cost of plan review and permit issuance. No Miscellaneous Work fees shall be charged for work which has been included in the scope of an all-inclusive building permit.
 - Fences and Walls - \$60.00
 - Signs- \$75.00
 - Bill Boards- \$250.00
 - Decks (open)- \$75.00 (Structure only, no electrical, etc.)
 - Decks (covered)- \$150.00 (Includes electrical, etc.)
 - Driveway Permit: \$25.00

- Window/Door Replacement-\$60.00
- Demolition- \$100
- Site Plan Permit- \$8 per \$1000 project cost
- Moving Structure- \$8/\$1,000 Building Value (\$100 Min + Trade Fees)

Commercial or Business Outdoor Activity Event or Events Fees

- One Day Event:
 - \$50- Resident/Business
 - \$150- Non-Resident/Non-Business
- Special One Day Event:
 - \$500 (Require closing of streets, additional preparation of the Town's police officers, firefighters, employees, agents or contractors; additional fees may be assessed to cover the Town's costs for assistance or services)
- Two Day Event:
 - \$100- Resident/Business
 - \$200- Non-Resident/ Non-Business
- Three Day or More Event:
 - \$150- Resident/Business
 - \$450- Non-Resident/Business
