#### **CALL TO ORDER**

## **Historical Society Lease Agreement**

Attorney Dillner reported, as discussed in Committee, the Village agreed to renew the lease with the Historical Society on the same terms with the exception of a monthly rental of \$225 instead of \$1.00 and the Village to pay all utilities. If approved by the Board, the Village will send it to them for acceptance. If it's not accepted, it will be brought up again at the next meeting.
