

**RESOLUTION AUTHORIZING ACCEPTANCE OF
APPLICATIONS FOR CANNABIS LICENSES BETWEEN
FEBRUARY 15 AND MARCH 15**

WHEREAS, the Borough Council has adopted an ordinance to authorize the issuance of cannabis licenses in the Borough, subject to the conditions and restrictions set forth in the Ordinance; and

WHEREAS, the Borough Council previously authorized the acceptance of applications for prospective licensees for 30 days in November 2022, and now desires to authorize another period for the acceptance of applications; and

WHEREAS, the Cannabis Sub-committee has prepared an application form to be completed by applicants for said cannabis licenses; and

WHEREAS, all applicants for cannabis licenses shall complete the application form and submit their applications solely through an online portal (applications will not be accepted in-person in Borough Hall); and

WHEREAS, the application form and accompanying instructions shall be made available on the Borough's website for viewing and submission; and

WHEREAS, the Borough has already issued letters of support for two (2) applicants for a Class 5 (retail) license, which is the maximum authorized by ordinance, so that no further applications for a Class 5 (retail) license will be accepted or considered by the Borough; and

WHEREAS, the Borough Council, in order to provide for an efficient and controlled application process, desires to set control dates for applications to be submitted to the Borough; and

WHEREAS, the control dates shall be February 15, 2023 through March 15, 2023, during which applications shall be accepted for consideration;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Tinton Falls in the County of Monmouth, State of New Jersey that:

1. Completed applications for cannabis licenses, except for Class 5 (retail) licenses, shall be accepted beginning on February 15, 2023 and ending on March 15, 2023.
2. All applications shall be made through the approved application form and shall be submitted solely through an online portal (applications will not be accepted in-person in Borough Hall).

3. The application shall be provided, along with accompanying instructions, on the Borough website and made available to the public.
