"Citizen Input: Senate Bill 1074 - Racial Profiling"

The 77th Texas Legislature enacted Senate Bill 1074 which prohibited the practice of racial profiling by law enforcement agencies. This legislation, effective September 1, 2001, additionally required law enforcement agencies to adopt a policy on racial profiling, implement policies whereby people can make a complaint if an officer has racially profiled, and the bill mandated that law enforcement agencies submit an annual report to their municipality's governing body which details data gathered pertaining to racial profiling.

The Tomball Police Department takes seriously its commitment to serving our community in a fair, impartial and unbiased manner. Every time a Tomball officer makes a traffic stop, consistent with Texas law, he or she completes racial profiling data collection form. Our complaint process is transparent, and consistent with best practices in United States law enforcement. The Tomball Police Department has a long history of working in partnership with members of the community, and we continually strive to excel at our mission of delivering the highest quality police service to all. To that end, and as a means of assessing our effectiveness in policy development and employee training, we are always eager to receive public feedback regarding our service delivery.
