Conduct a public hearing of the City Council of the City of Tomball to consider the advisability of the creation of a Public Improvement District to make certain improvements over certain property located with the City to be established as Graylou Grove Public Improvement District No. 15 (PID 15).

## **Background:**

Per Chapter 372 of the Texas Local Government Code, prior to the creation of a Public Improvement District (PID), the City of Tomball should hold a public hearing regarding the advisability of the proposed district.

FLS Development, the developer for the Graylou Grove development, has submitted their petition for annexation and PID and application for a Planned Development. The annexation was accepted at the July 7 City Council meeting with a scheduled public hearing and first reading of the ordinance on August 4. The second reading of the annexation will be conducted pending the Certificate of Convenience and Necessity (CCN) transfer being completed.

The Planned Development was approved by Planning and Zoning on July 14, 2025, and first reading of the Ordinance for adoption was conducted on July 21, 2025, with the second reading scheduled pending annexation.

This item is to conduct a public hearing to consider the advisability of creating the Graylou Grove Public Improvement District No. 15. Following the public hearing, City Council will consider a resolution to create the requested PID however the item will not be brought before Council for approval until the annexation can be completed.
