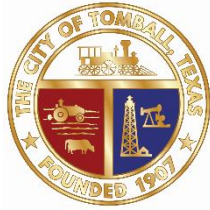


MINUTES OF SPECIAL CITY COUNCIL MEETING - WORKSHOP CITY OF TOMBALL, TEXAS

C. General Discussion

1. Presentation of design concepts from Westwood regarding Tomball Gateway and Wayfinding Signs.

Patrick Owens, Westwood Consultants provided design concepts for the Tomball Gateway and Wayfinding Signs. (Exhibit A)
2. Finance Director Bragg Farmer presented the Quarterly Financial Report for period ending June 30, 2025.

Fire Chief Joe Sykora presented Item C.4. for discussion only- A contract with the Siddons Martin Emergency Group for the purchase of a Pierce Custom Velocity 100' Mid-Mount Aerial Ladder Truck through the Houston-Galveston Area Council Contract # FS12-13, for a not-to-exceed amount of \$2,684,698.00, authorize the expenditure of funds therefor, and authorize the City Manager to execute any and all documents related to the expenditure. This amount will not be expended until the completion of the apparatus which is projected in September of 2029, within fiscal year 2029.
