# Tomball Legacy Square Advisory Committee Operating Guidelines

#### **PURPOSE**

The Tombali Legacy Square Advisory Committee (TLSAC) is established to provide a representative voice of the community and to advise the Tomball Economic Development Corporation (TEDC) Board of Directors and the City Council on matters related to the redevelopment of the former First Baptist Church campus.

The committee's ourpose is to ensure that community values, ideas, and feedback are incorporated into the planning and implementation of the Legacy Square redevelopment "LSAC will offer insights on design, land use, activation, and long-term operation" o help ensure the project reflects Tomball's character, heritage, and vision for the future.

#### COMMITTEE SIZE AND COMPOSITION

The TLSAC shall consist of 12 stakeholder members representing a balanced mix of community perspectives, including:

- Residents of the City of Tomball;
- Bus ness (wners within the City or immediate vicinity;
- Cycan, onprofit leaders;
- Subject the tter experts relevant to urban redevelopment, design, and community activation.

To ensure youth engagement and representation of future generations, two (2) of the twelve stakeholder members shall be youth members (aged 15–24).

In addition to the 12 stakeholder members, the committee shall include:

- Taree 3 members of the TEDC Board of Directors; and
- One (1 ember from the Tomball City Council.

#### SELECTION PROCESS

Membership on the TLSAC shall be determined through an open application process with clear eligibility criteria. Applicants will be evaluated on the following considerations.

- Residency or business ownership within the Tomball area;
- Demonstrated community involvement or leadership.
- Diversit if background, expertise, and perspective;
- Commitment to public service and collaborative engagement.

#### MEETING FREQUENCY AND OPERATIONS

During the promit's initial stages, TLSAC will meet bimonthly (every two months). Meetings will be held on the third Thursday of the month at 10:00 a.m. at the Tomball Economic Development Corporation office located at 29201 Quinn Road, Etc. A, Tombal 77375.
